FAMILY SERIES PRODUCTIONS INCLUDED CENTER PRODUCTIONS LIKE "RUDOLPH THE RED-NOSED REINDEER," "RUTH AND THE GREEN BOOK," AND "STELLALUNA" AND TOURING PRODUCTIONS, INCLUDING "AANIKA'S ELEPHANTS" BEFORE IT PREMIERED ON BROADWAY AND "ROCKEFELLER PRODUCTIONS' SESAME STREET THE MUSICAL". NEW DIRECTIONS SERIES PRODUCTIONS INCLUDED THE CENTER'S "THE GHAFTLY DREADFULS" AND "XPERIMENTAL PUPPETRY THEATER," ALONG WITH TOURING PRODUCTIONS LIKE "PACKRAT".
