FAMILY SERIES PRODUCTIONS INCLUDED CENTER PRODUCTIONS LIKE "RUDOLPH THE RED-NOSED REINDEER," "THE CAT IN THE HAT," AND "HAROLD AND THE PURPLE CRAYON", CO-PRODUCTIONS OF "ROCKEFELLER PRODUCTIONS' SESAME STREET THE MUSICAL" AND "PANCHO RABBIT AND THE COYOTE," AND TOURING PRODUCTIONS LIKE "GALAPAGOS GEORGE" AND "MILO THE MAGNIFICENT." NEW DIRECTIONS SERIES PRODUCTIONS INCLUDED THE CENTER'S "THE GHASTLY DREADFULS" AND "XPERIMENTAL PUPPETRY THEATER," ALONG WITH TOURING PRODUCTIONS LIKE "MAROONED".
